4. Description of proposed Infrastructure

What do you want to provide for the community?

Building on our recent success with our Community care farm in Assington, we would now like to increase our ability to provide more services for vulnerable people and the wider community by moving to a much larger site. Our project is to move to and develop further a Community Care Farm in Lindsey Suffolk on farm land that has been offered to us by a local landowner. The Red Rose Friends Community Farm will be located in the village of Lindsey near Hadleigh Suffolk. The farm will not only benefit the community in the immediate area but also the surrounding villages and at least the two market towns, Sudbury and Hadleigh. The Farm will provide the community with a venue for vulnerable people to learn transferable skills such as team work and increased confidence in a 'real life' context. As well as space for practising new skills and making friends, vulnerable people will be able to participate in the 'Farmer for the Day' and take part in animal care and gardening activities. This will be the only Community Care Farm in Babergh.

There is evidence of the positive relationship between exposure to nature and an individual's health. The successful combination of natural landscapes contact with animals and a meaningful workplace means that the Friends Community Farm can offer much variety to participants. Mental health benefits consist of improved self-esteem, improved well-being and improvement of mood with other benefits including an increase in self-confidence, enhanced trust in other people and calmness. We already have case study evidence that those attending the farm have improved physical fitness and better mental health.

Increasing support for and access to a wide range of care farming activities for vulnerable and excluded groups in the community will produce substantial economic and public health benefits and reducing pressure on statutory services.

We anticipate the space being used by other local community groups, schools and voluntary organisations, therefore reaching a larger amount of people within the community.

The community will have access to a wide range of volunteering opportunities within the farm, including feeding and caring for the animals and working with vulnerable people. As well as providing job and volunteering opportunities for the community there will also be the opportunity to work with other local businesses to offer their services from the farm, for e.g- carperntry, pottery, art classes.

We will be growing and selling our own fruit and vegetables which will be sold to the local community.

5. Project Aims

What is the purpose of the project? What are the community benefits that you want to provide?

The main purpose of the project is to provide daytime services for vulnerable people, including those with a learning disability and /or autism, those with ill mental health, dementia patients and others who may benefit from short term placements on their road to recovery from ill health. It will also offer opportunities for local schools to take part in a Forest Schools project, daytime sessions for families and housing tenants living in the Babergh district. The Farm will provide a safe and welcoming place where people will have close contact with animals, benefit from the therapeutic nature of gardening, animal welfare and the outdoors. Our specialist training programme centered around this project enable beneficiaries to gain skills in a wide range of subjects. We will provide training in market gardening, livestock handling, catering, retail and hospitality. We will invite local interested members of the community including representatives from the parish council, local primary school, local residents and businesses to engage with us. We already have a presence at Sudbury farmer's market selling the produce that members have grown or made. plants, herbs, bird boxes etc. The income gained from this small social enterprise project has enabled us to provide special trips out for members and volunteers to thank them for their contribution. We hope that with a much larger site that other such projects will emerge from the project. We think that these will include flower and vegetable growing areas, growing specialist herbs, vegetables and flowers for sale and the supply of eggs to the local community, but as with all our work this will be determined by those involved in shaping and driving. We are delighted to have been chosen by a local hotel and restaurant to supply herbs for their meal preparation. (Angel -stoke by Nayland) This and

other social enterprises will create a new income stream whilst delivering training and employment opportunities for vulnerable adults.

8. How have you identified need and support?

We pride ourselves on listening to our members and all of our current services have been developed as a result of engaging with those who benefit, giving them opportunities to shape the services. We completed a comprehensive survey /questionnaire with all our members and the overwhelming evidence was that a Community Farm was something that held huge appeal.

The Chief Executive Officer of TBS is also the Chair of Hive, which is a local charity providing services to local voluntary sector organisations. Through this avenue we have been able to ask local groups their views about this project and whether there was a need. Overwhelmingly the feedback was that this project would benefit a multitude of people in the local area. We already engage with the local High and Primary schools in and around Sudbury providing food parcels to two primary schools to help feed families who are living in poverty; two special schools, a local farmer, local residents and parent carers .

We have also attracted interest from our exisiting volunteers. We have an excellent record of volunteer recruitment. In the course of our usual volunteer recruitment we canvassed interest in a Community farm and the response was very positive, with a number of people already offering their expertise, including retired professionals offering to pass on their skills. All our volunteers are excited about a move to Lindsey, seeing so much more potential on a larger site. As an established organisation we have always encouraged feedback from all those using and or benefiting from our services. We have volunteer and member forums every six weeks in all our community Hubs to invite feedback and suggestions for improvement, or new services to consider.

We are looking at setting up a new group of representatives from varied local communities. e.g a member from the Parish council, a local Primary School and the local MP who is already familiar with our work and fully supports this project .The landowner has already engaged with the Parish Council and local residents and has received positive feedback. We will contact local businesses, prospective volunteers and anyone else who would like to be involved in the shaping of the new Red Rose Friends Community Farm Hub.

We have the backing of the Mental Health team who have praised our work with women suffering with their mental heath.

We had over 40 letters of support from local people and other organisations for the community for our farm in Assington. (Please see samples attached). Those members and volunteers who are attending Assington will move with us to Lindsey One local business was so impressed with our work at the Community farm that they

made us their Charity of the Year this year and are raising funds for small pieces of equipment.

We are blessed with a number of dedicated volunteers who have already agreed to volunteer at our new farm. We are also fortunate to have been offered some help to get the site ready by the owner James Buckle who has a farm staff team. A local tradesman has also offered his time at weekends to help us set up. Once the farm is up and running, we anticipate that many of the local people who already expressed an interest will become regular volunteers.

December 2022 Celebration day for local residents and invited guests

15. How do you expect the proposed Infrastructure to be maintained/funded in the years following completion of the project?

Currently we sell our leisure placements by way of membership fees and by spot purchasing of day places from Suffolk County Council. The new Red Rose Friends Community Farm will increase trading by offering day places and memberships, paid for training places, Forest School fees, sale of produce . Ultimately, we will run Bee keeping and ceramic classes. We will also increase income by the sale of food and other products. Based on our extensive experience of over 32 years of operating as a charity in Suffolk, we anticipate that week day places, activity days e.g be a farmer for the day and sales will cover the running costs. We hope that possibly, eventually short-term accommodation in the portacabins on the farm for vulnerable adults to gain a level of independence will attract additional income. We also plan to use the classroom portacabins to teach hospitality skills to those members who wish to gain a gualification on their day placements. We think that the input from the local community and steering group may better determine how to and what projects are likely to be piloted to increase income. The land has been provided by a local Farmer who is charging a minimal annual rent and who is fully supportive of The Befriending Scheme and of the Friends Community Farm project.
